Dates for regional judging events

WFHO meeting

The Stallion Inspection 2009 will be held from 8 – 10 January in Leeuwarden. An outline of the program is given in the newsletter for all foreign members. The meeting of the Other Foreign Countries Region and the WFHO meeting are scheduled for Friday morning, January 9 and will be followed by the clinics.

One of the points on the agenda for the WFHO meeting is the adoption of the charter that is now being prepared by the board of the WFHO and which you will be sent in time before this meeting.

Should any of the associations have any points to be added to the agenda for the WFHO meeting, we ask that these be submitted to Marja Teekens (marjateekens@fps-studbook.com) no later than December 1, 2008.

The period in which the Stallion Inspection is held is always a good time to bring up any questions and matters that may be unclear. In your e-mail, be sure to tell us what you would like to discuss so that everyone can prepare properly.

KFPS fees for 2009

The fees for 2009 will be adopted during the meeting of the KFPS Council of Members that will be held in November 2008. A new bonus arrangement for foreign associations was established in 2008. There are two major differences between this and the current situation. The first is that foreign associations will receive a bonus for their services. This bonus will be financed by the inspection fees: the Dutch fee will be passed on to the foreign members and then the foreign association will immediately be reimbursed 80% of the inspection fees for foals, mares, geldings and stallions. This also applies to the fee for linear scoring. The second major change concerns the deposit money charged for the studbook papers. Starting in 2009, the foreign associations will manage this deposit money themselves. This means that it will have to be collected when a new paper is issued and that it will have to be paid later once a paper has been created to ensure that managing the deposit money runs smoothly:

Management of deposit money by foreign associations

The fees charged Dutch and foreign members are being equalized as part of the new organizational structure. One of these fees is the "deposit money" that the owner pays as a security for studbook documents. As soon as the studbook documents are resubmitted to the association, this deposit money, including the administration costs ("sales costs") can be returned.

As arranged with the associations, they will start being responsible for managing this deposit money themselves on January 1, 2009. An advantage to this is that their members will not be paying as much in banking costs for international payments. Another advantage is that this procedure will make it possible for these members to receive their papers sooner. Although foreign associations will be incurring somewhat higher administration costs, this will also be accompanied by certain advantages:

- This gives the foreign associations more liquid assets.
- In reality, it always turns out that more deposit money is submitted to the association than has to be refunded, so the foreign association can keep the difference.

Here is the procedure for managing deposit money. By following this procedure, all associations will be managing their deposit money in the same way.

Procedure for transferring studbook papers to a new owner

- 1. Papers arrive at the association.
- 2. Foreign association sends papers to the KFPS.
- 3. Meanwhile, the foreign association sends an invoice to the new owner:

- 5. The new papers/passport will be sent to the foreign association.
- 6. The foreign association will then send the papers/passport to the new owner as soon as it receives the payment of the invoice.

If the **owner most recently listed** on the studbook papers is still a **member** of the foreign association and if the **Transfer Statement** is dated after **January 1, 2009**, the association will send a credit note. (A benefactor will not receive a return on a deposit.)
